Discussions:

- 1. The discussion between all the attendees have taken place with respect to the outstanding of:
 - a. NAMDHARI FOOD INTERNATIONAL PVT LTD Rs. 53.07 Crs.
 - b. NAMDHARI RICE & GENERAL MILLS. Rs. 10.75 Crs.

Mr. Inder Singh stated that so far they have paid their first weekly installment for both the above mentioned firms.

- 2. Mr. Inder Singh and Mr. Daljit Singh, stated that they are finding it difficult for arranging funds as they are declared defaulter and finding it difficult for arranging working capital from the banks.
- 3. Total Bank Liabilities are as follows:
 - a. NAMDHARI FOOD INTERNATIONAL PVT LTD Rs. 100.00 Crs.
 - b. NAMDHARI RICE & GENERAL MILLS. Rs. 23.00 Crs.
- 4. Mr. Inder Singh and Mr. Daljit Singh stated that they have intention for setteling the dues and want their name to be cleared from Defaulter list and for this they have started doing valuation for their entire paddy business.
- 5. Mr. Inder Singh and Mr. Daljit Singh stated that within 1 week they will submit copies of Title Deed, Factory Doc, balance sheet, Land Doc and photograph of mills and machinery.
- 6. They stated that they are ready to give stake in their business and wants to invite the investor and also ready for creating the private equity and accordingly they will settle entire pending NSEL dues.
- 7. Namdhari Basmati Rice and Satyug Basmati Rice are there main brands.
- 8. At present there rice mill is operational and close to 300 workers are working.
- 9. NSEL advised them to regularly pay weekly payments and then we can try to clear their name from defaulter list.
