Accordingly, an affidavit is filed by him.
- On the last date of hearing, Mr. Mohit Agarwal had also given the oral undertaking to furnish the Books of Accounts by 31<sup>st</sup> December, 2015. It was expected by the Committee that Books of Accounts would be furnished. Till today no Books of Accounts are produced. However, 31<sup>st</sup> December, 2015 being the outer limit, we propose to adjourn the present proceedings to 9<sup>th</sup> January 2016 at 2.30 p.m.
- By that time, Mr. Mohit Agarwal is also expected to file undertaking in relation to BRIZO as already undertaken by him as referred above. Needless to mention that NSEL has also issued reminder letter to Mr. Mohit Agarwal and his Advocate on 12<sup>th</sup> December, 2015 reiterating the necessity of compliance with the direction issued by the Committee on his part.
