## ORDER SHEET NO. 17G (Dated 22<sup>ND</sup> January, 2015)

- 1. Pursuant to the statement made by Ms. Mangala Gunjan, Advocate, who had appeared for Mr. Kailash Agarwal on 20th January, 2015 and to honour the said statement made by his advocate, Mr. Kailash Agarwal appeared in person along with Mr. Pravin Gaikwad and Mr. Rizwan Merchant, Advocates.
- 2. Mr. Agarwal submitted that the account books are seized by the Directorate of Enforcement and Income Tax Department. However, in support of his statement, he could not submit any document. Anyhow, he agreed to approach the said authorities to obtain copies of the Books of Accounts said to be not in his custody. In view of this statement, Committee has no objection, if Mr. Agarwal approaches both these authorities to seek copies of the Books of Accounts. Needless to mention that if the account books are seized by either of the authorities, they are expected to grant copies of the same to Mr. Kailash Agarwal for being produced before this Committee.
- 3. Mr. Kailash Agarwal has given an undertaking to this Committee that he shall not press his application for travelling abroad pending before the MPID Court. He further stated that as and when he would desire to travel abroad, he shall seek permission from this Committee in addition to the permission of any other authority as may be required. Written undertaking given in this behalf is taken on record.

4. Mr. Kailash Agarwal has also filed an application stating therein that the stock lying in the warehouse at Ludhiana is not owned by him and that the same is not in his possession.

5. Notwithstanding above statement, while reacting to the offer letter submitted by M/s. Tirupati Balaji Exim Pvt. Ltd. dated 22<sup>nd</sup> January, 2015 he submitted that the said offer is not the offer commensurate with the market price of the stock lying in the Warehouse. Though Mr. Agarwal has given no objection for disposal of the said stock said to be not owne?d by him, however, he desired to inspect the same. He also desired to submit reserve bid so as to see that the market price of the stock is realized. Statement made and application made on this count is taken on record.

EOW is directed to permit inspection of the goods in presence of the officers of NSEL to Mr. Kailash Agarwal including weighment of the stock lying in the Warehouse. Mr. Kailash Agarwal, with his advocates, tried to bring the statement made by his earlier advocate Ms. Mangala Gunjan underdoud. However, at this stage we do not propose to go into that issue for want of adequate material.

7. Mr. Kailash Agarwal made a statement that he has also filed a suit in the Court at Ludhiana against NSEL. However, no document in this behalf is produced. The Committee at this stage does not feel it necessary to go into this issue. Vakalatnama filed by Mr. Gaikwad, Advocate, is taken on record.
