- 3. Be that as it may, Mr. Naik for NSEL is requested to hand over one additional set of documents to Mr. Bharati, Advocate so as to enable him to respond on the next date of hearing i.e. by 18th February 2015.
- 4. As directed by the said Order Sheet No.l6-D, dated 20th January 2015, Aastha Minmet India Pvt. Ltd. and Juggernaut Projects Ltd. had handed over copies of their ledger accounts for the period 2011 to 2014 to NSEL. NSEL was directed to respond to the same, however, Mr. Naik could not respond and he seeks further time. Accordingly time is granted till 18th February 2015.
- 5. Mr. Naik has filed an Application No.22 of 2015, copy of which is handed over to Mr. Bharati, Advocate for being given to

Mrs. Shilpa Mohit Agrawal. In addition to this Committee directs that a notice be issued to Mrs. Shilpa Mohit Agrawal with a direction to appear before this Committee on 18th February 2015 at 2.00 p.m. and to file reply to the said Application No.21 of 2015.

- 6. NSEL has also moved an Application No.23 of 2015 seeking direction to identify and disclose movable and immovable assets including the Bank Accounts with respect to Aastha Minmet India Pvt. Ltd. and other group companies. Copy of this application is also handed over to Mr. Bharati, Advocate who is expected to reply to the said Application by next date of hearing i.e. 18th February, 2015.
- 7. Application No.19 of 2015 is kept pending for consideration. The same shall be considered after receipt of the return which Mr. Bharati has undertaken to file by 18th February, 2015
