- 1. Mr. Govind B. Solanki, Advocate appeared on behalf of LOIL Overseas Food Ltd., LOIL Health Foods Limited, LOIL Continental Foods Limited (LOIL for short). He submitted letter dated 3rd December, 2014 addressed to the Committee challenging the jurisdiction of this Committee as well as the liability sought to be set up by NSEL.
- 2. Mr. Solanki alsoinformed that LOIL has already approached the Competent Court in Fatehgarhsahib (Punjab) by way of a Civil Suit and that the Hon'ble Court has directed no coercive steps in any manner can be taken against the said firms. Needless to mention that while constituting this Committee by the Hon'ble Bombay High Court, a specific direction is issued to this Committee not to take any coercive steps. In this view of the matter apprehension of the noticees that this Committee is going to take any coercive step is without any foundation. However, this Committee is well within its jurisdiction to seek certain clarifications and information from the notice LOIL.

Consequently, the following directions are issued with direction to report compliance thereof by next date of hearing.

- 3. LOIL shall respond to the compilation of documents submitted by NSEL, copy of which is already furnished to Mr. Solanki, Advocate.
- 4. LOIL shall produce Ledger Account of NSEL maintained by them in the Books of Account of all their establishments. LOIL to file affidavit disclosing therein all the assets held by the Company, proprietorship and/or partnership concerns as well as personal assets of the proprietor, partners and Directors of LOIL group companies.
- Directors of LOIL group companies are directed to appear with their Advocate before this Committee on 22nd December, 2014 2000 m.
