- 3. In the above view of the matter following directions are issued to Mr. M. Sampatrao, Proprietor of MSR for reporting compliance on the next date of hearing.

  - (b) MSR to file affidavit disclosing therein the assets held by the proprietorship concern as well as personal assets of the proprietor M. Sampatrao.

- MSR to indicate how they propose to satisfy the (c) admitted liability of NSEL to the extent of Rs.8.82 crores, admitted vide their letter dated 1st August, 2013.
- MSR to indicate how the stock lying with them could (d) be liquidated and approximate market value thereof.
- MSR to produce record of the warehousing showing (e) remaining of the stock held in the warehouse in relation to NSEL in the past 2 years.
- EOW is also directed to get in touch with their 4. counterpart at District Warangal to find out the whereabouts of Mr. M. Sampatrao who is reported to be absconding. Mr. Misra Advocate appearing for Mr. M. Sampatrao states that his Client is not absconding and he is very much available. EOW to report on the next date of hearing as to what steps are taken by it to arrest Mr. Sampatrao.
