ORDER SHEET NO. 46B (Dated 27th November, 2015)

- Mr. Rajesh Mehta had appeared on the last date of hearing i.e. on 19th 1. October, 2015 and stated that he has given 7 properties as collateral securities to the NSEL vide Settlement Agreement dated 24th October. 2014 and those properties can be taken over and liquidated for payment of amount due and payable to the NSEL. In other words, those properties can be disposed of in accordance with law.
- On the request of Mr. Rajesh Mehta, one more opportunity was given 2. to him to file an affidavit making his stand clear. Today, he is absent, though he was directed to remain present in person and called upon to file the affidavit if he wants to make a contrary statement. No affidavit taking contrary stand is filed on record by Mr. Mehta.
- Notices were issued to Mr. Jayeshkumar Budhalal Mehta, Mr. 3. Prakashkumar Budhalal Mehta and Ms. Kalpana Jaishkumar Mehta directing them to appear before the Committee. All of them are absent in spite of service of notice.
- On the above backdrop, The Committee finds that there is no material 4. before the Committee to deviate from the statement already made by Mr. Rajesh Mehta before the MPID Court.
- In this view of the matter the Committee has no option but to make 5. appropriate recommendation to the Hon'ble High Court to dispose of the properties offered by him for disposal to liquidate his liability.
