ORDER SHEET NO. 23A (Dated 14th March, 2015)

- 1. Heard Mr. Anil Lalla, Advocate, appeared for Mr. Shrieesh Betgiri. He files an affidavit in reply on behalf of Mr. Betgiri admitting therein the receipt of money by way of loan from Mr. Rajiv Todi in the sum of Rs.2,70,00,000/- (Rupees Two Crores and Seventy Lakhs only), the details of which are given in the Affidavit. The copy of MOU is also produced on record.
- 2. The Committee, after having gone through the said Affidavit, finds that the material facts and particulars which are required to be disclosed have not been sufficiently disclosed.

Mr. Lalla, after taking instructions from Mr. Betgiri (who is present before the Committee), make a statement that in order to show his bonafides Mr. Bedgiri will pay / deposit a sum of Rs.25,00,000/- (Rupees Twenty Five Lakhs only) with the Committee by Demand Draft of Nationalised Bank drawn in favour of National Spot Exchange Ltd. Escrow Account with Axis Bank Ltd., Fort Branch. Mumbai having Account an No.913020036726487 (IFS Code UTIB0000004) within six weeks from today. The statement made is accepted and taken on record.

4. Mr. Betgiri is directed to file an affidavit disclosing all his properties available in India including the Bank Accounts held by him along with his all family members, in their joint or individual names. He should also furnish details as to how the amount paid by Mr. Rajiv Todi was utilised by him.

5. The Committee is of the opinion that at this stage, it is not necessary to direct Mr. Betgiri to disclose the details of his properties other than in India since he has agreed to deposit a sum of rs.25,00,000/- to show his bonafides within a period of six weeks and has also agreed to cooperate with the Committee. In the event of his failure to comply with these directions, further directions can always be issued. The attachment of his Pune properties to continue.
