- In the above circumstances, the Committee has no option but to recommend to the Hon'ble High Court to take note of the fact that the Officers of EOW and the Competent Authority are not cooperating with the Committee and for suitable directions to them.

Apart from the above, EOW is directed to produce within one week entire record seized/recovered/received from Shri Radhey Trading Co. along with their sister concerns before the Committee.
