- Mr. Agre, Advocate has filed an affidavit of Mr. Sayeed A. Patel on behalf M/s. Rajena Agro Products Ltd., stating therein that the accounts books of the company cannot be produced since the possession of the property wherein account books are kept has been taken over by Kotak Mahindra Bank. Thus the Account Books are presently lying in possession of Kotak Mahindra Bank.
- In order to determine the liability of M/s. Rajena Agro Products Ltd., it is necessary to have the Accounts Books before the Committee.
- It is needless to mention that under the provisions of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (for short "SARFAESI Act"), what can be possessed by the Bank is only the mortgaged property, namely the immovable property, not the Account Books lying therein.
- The borrower of the Bank and the alleged defaulter before the Committee is not willing to apply to the Bank to get the Accounts Books; obviously, with intend to avoid determination of its liability.
- In the circumstances, the Committee is of the view that it would be appropriate to make a request to Kotak Mahindra Bank to produce the Account Books of M/s. Rajena Agro Products Ltd. lying in the property possessed by the Bank under the provisions of SARFAESI Act.
- On the above backdrop, we direct that the notice be issued to Kotak Mahindra Bank requesting them to produce the Account Books in relation to the accounts of M/s. Rajena Agro

Products Ltd., their borrower and mortgagor, who had mortgaged the property with the Bank and ultimately, adjudged as a defaulter. Notice be made returnable on 10th October, 2015 at 2.00 p.m.

Mr. Sayeed A. Patel is also directed to disclose the other properties held by him with encumbrances thereon, if any, which he has offered as collateral securities under the agreement executed in favour of NSEL, details of which are as under:
