ORDER IN THE MATTER OF METKORE ALLOYS & INDUSTRIES LTD. (Dated: 8th July, 2015.)

- 1. The representative of SAIL was expected to appear today before the Committee to inform as to whether they are ready and willing to purchase the stock, in pursuance of their offer letter dated 24.1.2015.
- 2. Mr. Naik informed that in spite of making repeated approaches, there is no response from SAIL.
- 3. In the above circumstances, the Committee is of the opinion that there is no other option but to invite bids from open market by adopting tender process so as to dispose of the stock of steel.
- 4. In spite of repeated calls nobody is appearing for Metkore Alloys and Industries Ltd. Though they are served with repeated notices. No accounts books and other documents

required by the Committee are produced in spite of directions in this behalf. There is a complete non-cooperation on the part of the Metkore Alloys and Industries Ltd.

- 5. In the above view of the matter, the Committee is left with no other alternative but to recommend to the Hon'ble High Court to issue notice to Metkore Alloys and Industries Ltd. with a direction to appear and produce the accounts books and other documents before the Committee; so as to determine their liability to pay the dues due and recoverable from them. A report in this behalf shall be submitted to the High Court at the earliest.
- 6. EOW is also directed to disclose with regard to the transfer of credit balance lying in the account of Metkore Alloys and Industries Ltd. maintained with Axis Bank Account No. 913020021427061 and ING Vyasya Bank (now merged with Kotak Mahindra Bank) Account No.1600110115382.
