## ORDER SHEET NO. 30 (Dated 9th May, 2015)

- 1. Mr. D.N.Kar, Advocate holding for Mr. Masurkar, Advocate appeared and prayed for adjournment. His request for adjournment is rejected since the matter was adjourned on numerous occasions in the past at the behest of Mr. Sunil Didwania, M/s Horizonn Corporation Pvt. Ltd. and M/s Raghukul Enterprises. Sufficient opportunities were given to them to appear and put forth their submissions. In spite of granting sufficient opportunities, no steps are taken by them to appear before the Committee to indicate time schedule for discharge of their admitted liability.
- 2. The Committee finds it difficult to keep on adjourning the matters every time. The Committee found that no responsible person is made to appear. Sometimes junior Advocate appears, Sometimes his clerk appears only to pray for adjournment. No business is allowed to be transacted by the Committee.
- 3. In the above circumstances, since the liability is admitted one, Committee is of the opinion that appropriate report recommending recovery of the amount due and recoverable from Mr. Sunil Didwania, M/s Horizon Corporation Pvt. Ltd. and M/s Raghukul Enterprises needs to be made.
- 4. The notices were issued to M/s Rajena Agro Products Pvt. Ltd. The notices were returned with postal endorsement "Refused". The said service was accepted as good service by the Committee. Hence NSEL was directed to file its Affidavit in support of its claim and submissions. Accordingly, NSEL has filed an Affidavit dated 9th May, 2015. NSEL is directed to serve the copy of this Affidavit on M/s Rajena Agro Products Ltd. by registered post A.D. and one copy also to Swastik Overseas Corporation calling upon them to file their reply to the said application by 30th May,

2015 so that appropriate orders can be passed on the next date of hearing i.e. on 26th June, 2015 after hearing the parties.

- 5. Mr. Rajesh Mehta is directed to appear before the Committee on the next date of hearing since he has been avoiding to appear before the Committee on one pretext or the other.
- 6. Mr. D. N.Kar, Advocate has assured that he will inform and communicate this order to Mr. Rajesh Mehta and instruct him to remain present before the Committee on the next date of hearing. Statement made by him is taken on record. Order accordingly.
