## ORDER SHEET NO. 31C (Dated 26th June, 2015)

Pursuant to the notice issued by the Committee, learned Advocate appearing for Allahabad Bank appeared and filed a letter dated 8th May 2015 indicating therein that no property of

M/s Primezone Developers Pvt. Ltd., is mortgaged with them. However, it is informed by this letter that the Corporate Bank Guarantee for Rs.18 crores is issued by them in favour of M/s Sky High Infralands Pvt. Ltd., which is still alive. In this view of the matter no directions are required to be issued against Allahabad Bank as on date.

- Learned Advocate for Union Bank has also appeared and filed their affidavit bringing to our notice that four Bank Guarantees are issued by them, out of which two Bank Guarantees are due to expire on 23rd August, 2016 and balance two are due to expire on 18th March, 2018. We were informed that as on date the beneficiaries have not invoked the Bank Guarantees and that all Bank Guarantees are still alive. In view of non invocation thereof, as on date has no recovery against its borrower M/s Prime zone Developers Pvt. Ltd., In view of non-invocation thereof, as on date bank has no recovery against its borrower M/s Prime zone Developers Pvt. Ltd., In view of this scenario, both banks are are discharged. They need not appear before the Committee hence forth. However, it is made clear that if any order in relation to the finances made by them is to be passed, they would be given advance notice. It is not necessary to clarify any observation made by the committee to put Banks on Notice by way of abundant caution.
