ORDER SHEET NO. 13B

(Dated 19th December 2014)

- 1. Mr. S. P. Bharati, Advocate appeared for Aastha Minment India Pvt. Ltd. and its group companies and prayed for time to comply with the directions issued by this committee vide Order Sheet No.10A, dated 29th November, 2014.
- 2. He also appeared for Shri Radhey Trading Co. and their group companies. Mr. Naik appearing for NSEL made a grievance that the partners of Shri Radhey Trading Company did

not permit inspection of the goods lying in the warehouse and obstructed entry therein.

- 3. EOW has also reiterated the said complaint. With the result the intending purchasers could not inspect the chilly and black pepper lying in the said warehouse.
- 4. Mr. Bharati admits that one of the partners Mr. Pravin Arora did not permit inspection of the goods on the ground that the said partnership has to recover about Rs.3 crores by way of arrears of lease money from NSEL.
- 5. Mr. Bharati, Advocate appearing for Shri Radhey Trading Co. disclosed the names of two partners of Shri Radhey Trading Co. They are (1) Mr. Pravin Arora, son of Balkrishna Arora and (2) Mr. Ramesh Nagpal, son of Satpal Nagpal.
- 6. Both the above partners of Shri Radhey Trading Co. are directed to permit inspection of the stock namely; Chilly and Black Pepper lying in the warehouse notwithstanding the alleged arrears of lease money alleged to be due and recoverable from NSEL. The said issue of alleged recovery has nothing to do with the grant of inspection of the stock lying in the warehouse.
- 7. In the event the entry in the said warehouse is obstructed by the partners of Shri Radhey Trading Company, it would be open for the EOW and NSEL to take police help in view of the permission granted by the Hon'ble High Court in this behalf vide its order dated 17th December, 2014.
- 8. Mr. Naik appearing for NSEL has filed his response to the affidavit of Mr. Mohit Agarwal requesting a direction to call upon Mr. Mohit Agarwal and Ms. Shilpa Agarwal to provide the DMAT account statement in original along with the statement of

their related companies and entities. Mr. Bharati has sought time to respond to the said application. Accordingly time is granted.

- 9. All parties for whom Mr. Bharati, Advocate is representing are directed to produce their Account Books wherein the account of NSEL is maintained by them and also to disclose the details of the properties including that of the partners and their debtors/ clients so as to undertake the necessary audit of their respective accounts.
- 10. Some of the representatives of Investors' Association who were present, are also requested to get the best offers for the properties which are already attached and available for disposal to recover the dues of NSEL. They have assured committee to do needful in the matter.
- 11. The proceedings are adjourned to 20th January, 2014 at 2.30 PM at the same venue.
