- 1. Mr. Prakash Shah, Advocate appearing for Metkore Alloys and Industries Ltd. ("Metkore" for short) has filed an affidavit dated 14th January 2015. The copy of the said affidavit is handed over to Mr. Naik, learned Counsel appearing for NSEL with a direction to respond to the same.
- 2. Mr. Naik has sought time till 31st January, 2015. Accordingly time is granted to file the reply to the affidavit referred herein with further direction to produce the documents in relation to various transactions referred to in the affidavit.
- 3. The Committee has received two offers, one from SAIL and another from two different parties for disposal of goods. The offer received in a sealed cover was opened by the Committee and after examining the same and comparing with the offer given by SAIL, the same is re-kept in sealed cover again. The final recommendation on these offers would be considered on the next date of hearing after receipt of the reply to the affidavit filed by Metkore from NSEL.
- 4. The Committee vide its earlier order sheet no.13F, dated 19th December, 2014 had directed EOW to take steps to get the amount of Rs.44,00,000 transferred to the Escrow account of NSEL. EOW has informed that they have already written letter to the Banks requesting them to transfer the said amount to the Escrow account of NSEL and that they are pursuing the matter

with the Banks. In this view of the statement made, no further directions are necessary. However, EOW is directed to place the progress report in the matter by next date of hearing.

5. Proceedings are adjourned to 4th February 2015 at 2.00 p.m.
