## ORDER SHEET NO. 45A (Dated 19th October, 2015)

- Mr. Rajesh Mehta is absent though he was directed to remain present personally. Mr. Aditya Parab Advocate appeared for Mr. Rajesh Mehta and filed his affidavit along with the statement of Income for the years 2013-2014 and 2014-2015 along with the list of assets of Swastik Overseas Corporation with their valuation.
- Mr. Naik, learned Counsel for NSEL produced an Order Sheet recorded by the Special Judge, M.P.I.D. and Additional Sessions Judge in C.R.No.36 and brought to our notice that Mr. Rajesh Mehta was present before the said Court on 29th April, 2015 and that he made a statement that he has no objection if his properties of which values are given are sold for realization of the dues, due and recoverable from him and his wife.
- Mr. Naik, learned Counsel appearing for NSEL, has also brought to our notice the affidavit filed by Mr. Rajesh Mehta before the Special Judge under the MPID Act in the month of July 2014 wherein he has made a categorical statement that he has placed 7 properties as collateral securities with NSEL vide Settlement Agreement dated 24th January, 2014 and those properties can be taken over as security for the payment of the amount and may be disposed of in accordance with law.
- It is no doubt true that Mr. Rajesh Mehta appears to have made the aforesaid statement before MPID Court and that appropriate recommendations on the basis of the above statement of Mr. Rajesh Mehta can be made by the Committee to the Hon'ble High Court. However, with a view to give one more chance, Mr. Rajesh Mehta is finally called upon to file affidavit in support of his statement made before the MPID Court, stating therein that he has no objection to sell the properties of which he has given valuation,

including properties standing in the name of his wife, who is the proprietress of Swastik Overseas Corporation.

- The learned Advocate appearing for Mr. Rajesh Mehta undertakes to keep Mr. Rajesh Mehta present on the next date of hearing before this Committee. It is made clear to him that by way of last chance, 10 days' time is granted to file an affidavit referred to above. In case no such affidavit is filed, appropriate recommendations regarding his liability shall be made to the Hon'ble High Court.
- Having considered the material placed before us, issue notices to Mr. Jayeshkumar Budhalal Mehta, Mr. Prakashkumar Budhalal Mehta and Ms. Kalpana Jaishkumar Mehta returnable on 27th November, 2015 directing them to remain present before this Committee on the returnable date.
